# Action

**BACKGROUND INFORMATION:** School boards are now required by 2015 Wisconsin Act 55 to notify the parents/guardians of students enrolled in the school district of the student academic stands that will be in effect for the school year. Boards must provide this notification annually, prior to the beginning of the school term. The law states that the district may provide the notice electronically, including by posting the notice or a link to the specific academic stands on the school district's website. Also, the school board must annually include an item on the agenda of the first school board meeting of the school year (the first meeting after July 1,) that clearly identifies the student academic standards adopted by the board under section 118.30(1g) (a) 1 of the state statues that will be in the school year. This law change became effective 7/14/15.
